## 2004 HIGHLIGHTS

### ON-RESERVE MATRIMONIAL REAL PROPERTY INFORMATION SESSION

PLEA entered into an agreement with the Women's Issues and Gender Equality Directorate (WIGE) of the Department of Indian and Northern Affairs Canada (INAC) to organize and coordinate activities related to On-Reserve Matrimonial Real Property (OMRP). A conference was held in March, 2004, in Saskatoon, Saskatchewan and brought together approximately 20 participants from Saskatchewan and Manitoba First Nations to discuss this issue.

### YCJA ONE YEAR LATER PROJECT

The *YCJA: One Year Later*, is a publication that draws on case law, challenges, etc. from across the country, to address and account for on-going developments in the interpretation and application of the *Youth Criminal Justice Act* (YCJA). This resource is available in English and French.

### PLEA ANNUAL LAW WEEK LUNCHEON

PLEA's Sixth Annual Law Week Luncheon was held on April 6, 2004 in Saskatoon. Our guest speaker was prominent Canadian lawyer James Lockyer, Director of the Association in Defense of the Wrongly Convicted.

### CONSERVATION EASEMENTS

PLEA partnered with the Canadian Wildlife Service/Environment Canada; the Nature Conservancy of Canada; Saskatchewan Agriculture, Food and Rural Revitalization Lands Branch; Ducks Unlimited Canada; and Saskatchewan Environment to produce a series of newspaper articles on the topic of conservation easements. These articles ran in newspapers across the province that subscribe to PLEA's *A Look at the Law* newspaper article service.

#### WHAT IS PLEA?

The Public Legal Education Association of Saskatchewan (PLEA) is a non-profit, non-government, charitable organization which exists **to educate, inform, and empower through law-related education.**

PLEA provides **general information on the law** rather than legal advice for specific problems. Knowledge of the law (our rights and responsibilities) is a form of responsible citizenship. Public awareness of, and involvement in, legal issues can increase the effectiveness of our legal system. To this end, PLEA offers a number of services and materials.

PLEA offers **presentations** on various areas of the law through Free Legal Information Sessions at public libraries and regional colleges throughout the province, and through our Speakers Bureau service. Lectures are given by volunteer lawyers, government personnel, and other professionals.

PLEA produces **publications** on many areas of the law and makes these available to the public at no charge. PLEA also writes a **newspaper article series**, run weekly in many Saskatchewan newspapers.

PLEA's **Youth and Schools Program** strives to promote the integration of law-related education into the schools. We develop classroom resources and teacher education programs on teaching about the law.

PLEA receives funding from the Law Foundation of Saskatchewan and the Department of Justice (Canada). PLEA also enjoys the support of the Law Society of Saskatchewan, the Canadian Bar Association (Saskatchewan Branch), the College of Law, the Saskatchewan Legal Aid Commission, Saskatchewan Learning, Saskatchewan Justice, the Saskatoon Public Library, and libraries and regional colleges throughout the province.

PLEA strives to ensure that, by providing legal education to the public, the people of Saskatchewan, especially young people, have the basic level of legal literacy that will allow them to function in this complex society, for a democratic society depends on its members being well informed. Through the dedication of the Co-Directors, Doug Surtees and Joel Janow, and the wonderful staff, PLEA has continued to expand its creative projects and partnerships.

PLEA distributes booklets and pamphlets, teachers manuals and newspaper articles. Among many other projects this year we distributed 10,000 copies of our 188 page *Guide to the Law for Saskatchewan Women* and 6000 more copies are on order. Aboriginal PLEI has started a partnership with the Aboriginal Justice and Criminology Program at the University of Saskatchewan; and we have developed and revised materials with respect to youth justice information.

I would like to thank the Co-Directors and the staff for their energy and professionalism and their many talents. They have demonstrated an amazing ability to coordinate an extremely well-run operation.

PLEA relies heavily on the generous support of volunteers from the legal profession, judiciary and general public to deliver its services. We are grateful for the time and energy which so many have given to the work of PLEA this year.

The Law Foundation of Saskatchewan provides our core funding, making many of our projects possible, and we continue to be thankful for this support.

### INTERNATIONAL TRADE LAW

PLEA is revising this very valuable website and accompanying teachers' resource books. Preliminary consultations with the University of Saskatchewan Centre for Studies in Agriculture, Law and the Environment and Saskatchewan Learning have gone very well. The new edition of this material will be ready to go in 2005.

### FAMILY VIOLENCE INTERMEDIARY TRAINING GUIDE

With the support of the Department of Justice Canada's Family Violence Initiative, PLEA published the *Family Violence Intermediary Training Guide*. This free resource for persons working with victims of family violence contains information and resources related to domestic abuse, such as accessing help from the community, accessing the criminal and civil court systems, *The Victims of Domestic Violence Act*, as well as the legal system as a whole.

### NEW PUBLICATIONS

*A Death in the Family*: The death of a family member or close friend can be a traumatic and unsettling experience. In addition to the grief or personal loss, survivors also may have to make a number of pressing decisions about the affairs of the deceased person. This booklet is designed to address some of those things that may need to be done in the short term, after someone has died.

### SCHOOL LAW

Last year, Saskatchewan teachers told us that they would like a way to more easily invite Saskatchewan lawyers and judges into their classrooms. PLEA entered into a partnership with the Law Society of Saskatchewan, the Canadian Bar Association, and the Courts Education Program to make this happen. Teachers and students told us what topics they would like to discuss. Volunteer lawyers and judges, as well as PLEA staff visited over 20 schools to talk with students about issues like Human Rights, Sentencing Circles, Labour Law, Consumer Law, and Youth Crime. We visited schools in Northern communities like La Ronge, La Loche, Pakwaw Lake, and Patuanak. We also visited rural communities like Pense, St. Brieux, Lampman and Grand Coulee. Some of the larger communities we visited were Saskatoon, Regina, Prince Albert and Kindersley. In 2005, we look forward to matching many more volunteer lawyers and judges with students from all over Saskatchewan.

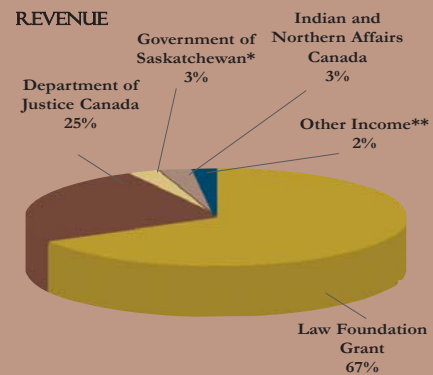

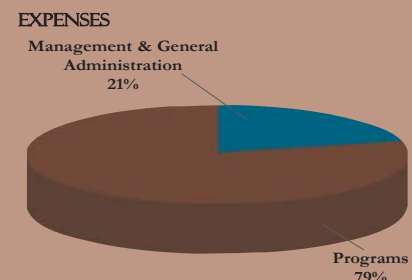
