## 2005 Highlights

- Newly published in 2005 was the Family Law Intermediary Training Guide, for intermediaries with clients dealing with family law issues. A new Power of Attorney booklet was published to replace the Power of Attorney pamphlet. In addition, 22 other publications have been revised, printed, and posted to the website.
- PLEA received funding from the Department of Justice Canada's Youth Justice Renewal Initiative to develop dedicated Youth Criminal Justice Act (YCJA) web pages for youth, schools, and adults. A main portal (Youth Justice Online - www.plea.org/ newyj/main.htm) and four separate web pages (Youth, Educators, Adults, and Professionals) were developed to facilitate improved on-line access to information about youth justice for the people of Saskatchewan. The main portal and "home" pages were designed to engage the user from point of entry, to stimulate curiosity and encourage further exploration through the site. Further to this, we included interactive features such as games, online workbooks, and test your knowledge sections. The end result is a site that is informative, but also innovative and fun to use! The very professional level of this web design demonstrates the high skill level of our support staff.

Another successful year of PLEA activities and programming has passed, and a major milestone was recognized. PLEA celebrated its 25th anniversary in June 2005. The past year saw us enter into an agreement with Saskatchewan's Office of the Treaty Commissioner to begin development of resources for teachers and schools so that the concept of treaties and their great significance in Canada can be better understood by today's generation. We will also strive to make more of our materials accessible in French. This has begun, and we are thankful for access to and translation services of Association des juristes d'expression française de la Saskatchewan (AJEFS).



In June, we hosted the Public Legal Education Association of Canada's (PLEAC) AGM and Conference. The Conference was a great success and brought together many from across Canada and even the United States with an interest in our field of work. The focus was on best and promising practices in the provision of PLEI. We took this opportunity to combine the events with formal observance of our 25th anniversary at a wine and cheese gathering. Here, we presented the inaugural Cam Partridge Memorial PLEA Volunteer of the Year Award to Regina lawyer, Mr. Rodger Linka for his tireless efforts in providing legal information sessions and speakers bureau presentations to the people of his community.

Of course, PLEA's work would not be possible without the continued strong support of the Law Foundation of Saskatchewan. Saskatchewan Justice also provides core financial support on a yearly basis. The Department of Justice Canada provides much project funding to bring PLEI to Saskatchewan. Also vital to our existence and efforts are the volunteer contributions of the Law Society of Saskatchewan, College of Law, Saskatchewan Legal Aid Commission, Saskatoon Public Library, public libraries and community colleges throughout the province, and the Canadian Bar Association Saskatchewan Branch. For all of this, we are extremely grateful.

In closing, we must extend congratulations and much thanks to former Co-Director Doug Surtees, now Professor with the University of Saskatchewan's College of Law, for twelve years of truly outstanding service to our organization. 

### 2005 Highlights continued

- PLEA received funding from the Department of Justice Canada's Child-centred Family Justice Fund to develop an electronic Family Law Intermediary Training Module (www.plea.org/famlaw) for intermediaries working with clients experiencing separation and divorce. The online resource is based on PLEA's Family Law Intermediary Training Guide. The training module is interactive, with an emphasis on the use of plain language and is easy to use. Each chapter also includes a Test Your Knowledge section so that users can track their progress through the resource.
- PLEA also received funding from Justice Canada's Child-centred Family Justice Fund to assemble and distribute a Family Law Kit for intermediaries working with clients experiencing separation and divorce. The kit contained materials from the Department of Justice Canada, as well as province-specific material from PLEA. We distributed 1000 kits to intermediaries throughout the province.

- The League of Peaceful Schools is strengthening its partnership with Saskatchewan Learning's
   "Caring and Respectful Schools: Toward School<sup>Plus</sup>", and is working with them to allow schools
   to more easily become League members. A new website for the League was also developed
   (www.leagueofpeacefulschools.sk.ca) with sections that include a members' communications
   gateway, links, membership information, and a news area.
- Our collaboration with Saskatchewan's Queen's Printer is now officially established, making access to our materials from their Electronic Publication Centre possible for all visitors to their website.
- Working with Saskatchewan Court Services and Provincial Court judges, we developed an
  informational pamphlet on Saskatoon's new Domestic Violence Court its process and treatment
  programs option. This resource will be available in Spring of 2006.

Currents: exploring traditional aboriginal justice concepts in contemporary canadian society looks at questions such as how societies make laws, resolve conflicts, and deal with those who do not live up to society's standards for behaviour, as well as how Canadian and International law recognize and protect certain rights. The law-making process, conflict resolution, justice and rights are all considered from both an Aboriginal and an Anglo-Canadian perspective. This is a middle years manual with some high school applications and is available in hardcopy, on our teacher's resource CD-ROM, or can be viewed, downloaded, or printed online (www.plea.org/yas/yashome.htm).



• TRADE! This website (www.schooltrade.org) has been written especially for Canadians, particularly Saskatchewan students and their teachers to explore how international trade contributes to the growth and lifestyle of the province. The website has four major topics: Why Countries Trade, Trade & Politics, Trade & Food, and Trade & the Environment. The site also includes Test



Your Knowledge sections specific to each topic with interactive quizzes, scenarios, short answer questions, as well as games and puzzles. There is also an accompanying resource for teachers which provides a user-friendly resource that outlines the website content while providing an overview of the concepts associated with international trade. In addition, the guidebook offers teachers a variety of strategies and activities to assist in the integratation of the website content into the curriculum.

- 1569 homepage hits to the Youth Justice Online website


