

The past year has again witnessed the strong efforts of our brilliant staff, working hard to maintain a very high level of service and ensuring we meet public demand to the greatest extent possible.

In these somewhat unpredictable economic times, in addition to the overwhelming support of the Law Foundation of Saskatchewan, we can also attribute this success to our stability and organizational infrastructure that we have been able to build and strengthen over the decades. Our bounty of wonderful friends, funders, partners, collaborators, colleagues, and counterparts across the land have contributed so much to making it possible to maintain our highquality, high-level programming. The past year has been a shining example of such relationships and the types of resources they can generate. Many of these are highlighted throughout this Annual Report.

Additional support from the Department of Justice Canada allowed us to print an important resource for survivors of sexual assault. The Saskatchewan Ministry of Health collaborated with us to produce

many needed resources on drugs, alcohol and laws regulating their use. Working partnerships with schools and other communities helped us raise awareness of our services and assisted us to identify legal information needs and how we may best meet them.

Our work in 2012 and beyond will include a crucial, major project to create a Self-Help Family Law Website, funded by the national Access to Justice Fund of the Law Foundation of Ontario. We are very excited about this opportunity and the difference we feel it will make in improving access to justice for countless Saskatchewan citizens.

From year to year, we wonder how we'll be able to top our past accomplishments. Yet we continue to do so – and expect to do so again in 2012!

In 2011, as in past years, PLEA has strived to fulfill our vision of providing legal information for everyone. This includes diverse groups from young people looking for straightforward information about drugs and alcohol, to sexual assault survivors needing guidance as they deal with the legal and medical aftermath of a sexual assault, to seniors requiring information on creating documents such as a Will, a Power of Attorney or a Health Care Directive.

Meeting the legal information needs of the diverse groups that make up the population of Saskatchewan requires not only producing resources that cover a wide range of topics but also requires developing a wide range of means of delivering plain language legal information. PLEA has achieved this through a variety of programs and services over the years.

We have a very successful Request a Speaker program that matches volunteer lawyers in communities across Saskatchewan with community groups that need a speaker to present a particular legal topic. Demand for this program has increased significantly over the past year, with many repeat users indicating a high level of satisfaction with this service. We also have a strong presence in school communities through our Youth and Schools Program. Our resources are available online through our user-friendly website, as well as in print, where appropriate, and we continue to develop new means to deliver online resources.
